MINUTES

BOARD MEMBERS PRESENT: Chair, Jay Johnson, Vice Chair, Larry Ruggiero, Gregory Cota, Mary White, William Schuyler, Kevin Posey, Vishal Aswani.

1. Announcement of deferrals and withdrawals: Docket item number 8, Parking on North Lee Street, will be deferred until the October Traffic and Parking Board meeting.

2. Approval of the minutes from the July 23, 2012, Traffic and Parking Board Meeting: Mr. Ruggiero made a motion to approve the minutes, seconded by Mr. Posey. The Traffic and Parking Board voted unanimously to approve the minutes from the July 23, 2012 Traffic and Parking Board meeting.

3. **STAFF REPORTS AND UPDATES:**

PUBLIC HEARING:

4. **ISSUE:** Request to post “NO PARKING BETWEEN SIGNS” at the driveways located at 24 and 26 East Reed Avenue.

PUBLIC TESTIMONY: No one from the public spoke.

BOARD ACTION: Mr. Posey made a motion, seconded by Mr. Cota, to approve the request to install the “NO PARKING BETWEEN SIGNS” restrictions at 24 and 26 East Reed Avenue. The motion carried unanimously.

5. **ISSUE:** Request to extend the no parking zone one vehicle length for two driveway entrances on the west side of South Reynolds Street entering into the West End Condominiums and the EOS 21 apartment complex, respectively.

PUBLIC TESTIMONY: No one from the public spoke.

BOARD ACTION: Mr. Aswani made a motion, seconded by Mr. Posey, to approve the request to extend the no parking zone 20 feet on both sides of each

driveway entrance into the West End Condominiums and the EOS 21 apartments on South Reynolds Street. The motion carried unanimously.

6. **ISSUE:** Request to remove six parking spaces on Dawes Avenue in between the Bisdorf Building and the Dawes Avenue Parking Garage on the NOVA Alexandria Campus.

PUBLIC TESTIMONY: No one from the public spoke.

BOARD ACTION: Mr. Schuyler made a motion, seconded by Mr. Aswani, to approve the request to permanently remove the six parking spaces on Dawes Avenue in between the Bisdorf Building and the Dawes Avenue Parking Garage. The motion carried unanimously.

7. **ISSUE:** Request to install 35 feet of “NO PARKING” signs on the East side of North Union Street beginning from the crosswalk on North Union and East Queen and proceeding north.

PUBLIC TESTIMONY: Anne ____ spoke in favor of the request.

BOARD ACTION: Mr. Posey made a motion, seconded by Mr Aswani, to approve the request to install 35 feet of “NO PARKING” signs on North Union Street at the North Union and Queen intersection.

9. **ISSUE:** Request to change the lane configuration on Slater’s Lane, between West Abingdon Drive and Portner Road to install bicycle lanes as consistent with the 2008 Pedestrian and Bicycle Mobility Plan.

PUBLIC TESTIMONY: Jonathan Krawl, Jerry King, Andres ____, and Scott Bindy spoke in favor of the request. Chris Steven spoke against the request.

BOARD ACTION: Mr. Posy made a motion, seconded by Mr. Schuyler, to approve the request to change the lane configuration on Slater’s Lane to install bicycle lanes between West Abingdon Drive and Portner Road.
