Transfer of Taxicab Vehicle Affiliation and Operating Authority

- Transfer requests must be submitted no later than November 15th to:

- Transfers may be requested only by the taxicab vehicle owner.
- Transfer requests must be certified by proposed receiving company for consideration.
- Transfer requests may be changed or withdrawn through November 15. After that date, all requests are final and may not be changed or withdrawn.
- Transfer requests will be approved or denied no later than December 15th.
- Approved transfers become effective on January 1 following approval.
- Transfers will not be allowed to take place until all financial obligations with current taxicab company are cleared. Financial obligations must be cleared by January 31.
- Approved transfers not completed for any reason by February 15 following approval will be subject to cancellation.
- In the event that approval of a transfer is canceled, the company originally assigned the associated taxicab vehicle authorization will have the option of retaining that authorization or allowing it to move to the receiving company.
- Transfers will not be considered complete until such time as the refitted taxicab vehicle is inspected and approved by the Hack Inspector for operation under the new company colors. Transfers not passing inspection before February 15 will be subject to cancellation.
- Transferring owners are strongly encouraged to schedule inspections before the February 15 inspection deadline to avoid last minute delays.
